

# \$1.3 Million for a Brighter Future in Northwest Dayton

For many families, homeownership is a dream that feels out of reach—especially in historically underserved neighborhoods like Northwest Dayton. To provide a clear path to financial stability through homeownership, the WPCU® Sunshine Community Fund® is proud to announce an initial investment of \$1.3 million to jumpstart a new program called the Northwest Dayton Pathways to Homeownership.

In collaboration with Omega CDC, CountyCorp, the HomeOwnership Center and other key community partners, this large-scale housing initiative will expand homeownership opportunities. Construction on 10 brand-new homes will begin in the summer of 2025, with a goal of 30 new or rehabbed homes across three years. These homes will be sold at market price, but eligible buyers will receive down payment and closing cost assistance to ensure that homeownership is accessible for local families.

"When you think about somebody who has never owned a home—and whose parents didn't own a home—now they have the opportunity to buy a great brand-new home they can afford," said Tracy Szarzi-Fors, Executive Director of the WPCU Sunshine Community Fund. "That level of stability and security is truly life-changing."

### InspiRAYtion Grants

The heart of the WPCU **Sunshine Community** Fund® is the InspiRAYtion Committee, a small group of dedicated WPCU® partneremployees who volunteer their time fundraising for and selecting finalists for InspiRAYtion grants. From those grant finalists, each WPCU partner-employee has the opportunity to place their individual votes to help determine which local nonprofit organizations will receive a grant.

At Home by High was created by neighbors for neighbors to support people aging in place. The organization serves the Short North in Columbus, Ohio and surrounding neighborhoods with helpful services for older adults, including home upkeep, social events and activities.

## FINANCIAL LITERACY TOOLS FOR A BRIGHTER FUTURE

Children who learn the basics of financial literacy early have a better chance of becoming more financially stable adults. That's why WPCU® Sunshine Community Fund® developed MoneyMagnifier®, a free student financial learning program designed to help educators meet Ohio's Financial Literacy Standards and empower students at every grade level.

Using our free curriculum that includes fun and helpful tools, worksheets and videos, educators help guide even the youngest students on their path to building positive financial habits.

Last year, after two MoneyMagnifier pilot programs were tested and evaluated, the curriculum has been enhanced and improved even more. MoneyMagnifier reached more than 2,600 students in 2024, with many more schools showing interest. Thanks to the WPCU Sunshine Community Fund, students are gaining a valuable early financial education that will pay dividends for the rest of their lives.
