WPCU Business Loan Application Guidelines:

- Loan requests up to \$100,000
 - · Completed Application
 - Additional documentation may be requested after initial review
- Loan requests greater than \$100,001 and up to \$200,000
 - Completed Application
 - · 2 years Personal and Business Tax Returns
 - 2 Months of Business Bank Statements**
 - Additional documentation may be requested after initial review
- Loan requests over \$200,001
 - Completed Application
 - 3 years of Personal and Business Tax Returns and Business Financials
 - · Personal Financial Statement
 - 2 Months of Business Bank Statements**
 - · Additional documentation may be requested after initial review
 - Call (800) 762-0047 to be referred to a Relationship Manager or email BusinessLoanServices@wpcu.coop

For all non-real estate loans ≤ \$200,000, please apply online at WPCU.coop/BusinessLoans. Existing business lending with WPCU may change the required documentation.

All loans are subject to credit review and approval.
