## OFFICIAL RULES WRIGHT-PATT CREDIT UNION, INC. "My HELOC Solution" Social Media Drawing Promotion February 1, 2021 through March 31, 2021

These are the official rules ("Official Rules") for the "My HELOC Solution" Social Media Drawing Promotion ("Promotion").

The eligible winner will receive one \$500 Visa gift card. One (1) other winner will be selected by random drawing on March 29th, 2021 from all eligible entries received starting at 9:00AM Eastern Time (ET) on February 1st, 2021 through 2:00PM ET on the date of the drawing. The eligible winner will receive one \$500 Visa gift card. The winner of one drawing will not be eligible to win any subsequent drawings in this Promotion. No prize substitutes are allowed. Each winner must comply with these Official Rules, including the requirements to claim the prize as provided in Section 5.

The promotion period will run from 9:00AM ET on February 1<sup>st</sup>, 2021 through 2:00PM ET on March 29<sup>th</sup>, 2021. The entry period for each drawing begins at 9:00AM ET on February 1<sup>st</sup>, 2021 and ends at 2:00PM ET on the date of each drawing (February 19<sup>th</sup>, March 10<sup>th</sup>, and March 29<sup>th</sup>, 2021). Limit one (1) entry per Eligible Participant during the entire promotion period. Multiple entries will not be considered and are void. Any entries received outside of the stated entry periods will not be returned.

## 5. To Claim Prizes:

The Credit Union reserves the right to disgualify any entrant found to be in violation of these Official Rules and to suspend, cancel, or modify the promotion if fraud, tampering, technical failures, or any other factors beyond the Credit Union's control compromise the integrity of the Promotion, in each case as determined by the Credit Union in its sole discretion. This Promotion is subject to all applicable federal, state, and local laws and regulations, and is void where prohibited by law. All stolen, lost, late, damaged, misdirected, noncompliant, incomplete, or illegible entries will not be considered and are void. Entrants agree that the Credit Union has not made any warranty or representation, express or implied, regarding any prize.
