How to Enroll in eStatements

You can access your account online and enroll in electronic delivery of statements and notices by setting up Mobile and/or Online Banking and enrolling in eStatements through your computer or mobile device.

To register your account for Mobile and/or Business Online Banking, visit WPCU.coop and look for "New Business User? Register Here" in the upper right-hand corner (please note this link will take you to another one of our websites) to fill out the Online Business Banking registration form. Once you've registered, you have two options to enroll in eStatements.
