Annual Business Meeting Minutes

The following minutes summarize the key discussions, decisions and strategic direction presented at Wright-Patt Credit Union's last Annual Meeting. As part of this year's meeting, members will vote to approve these minutes as an accurate record and to affirm their support for the decisions made and the continued direction of their credit union.

- Welcome: Timothy J. Mislansky, President and CEO, welcomed members of Wright-Patt Credit Union, Inc., (WPCU®), and guests, to WPCU's 2025 Annual Business Meeting. He shared that WPCU's purpose "Everyone deserves a caring financial partner who builds hope and improves well-being" guides everything we do for the credit union on behalf of those we serve. He introduced Board Chair Joe Linsenmeyer and MC for the meeting Holly Allen.
- 2. **Call to Order:** Joseph L. Linsenmeyer, WPCU Board Chair, called the meeting to order at 7:00 pm eastern time. The meeting was held virtually via a digital platform with live questions and answers.
- 3. **Declaring a Legal Annual Meeting:** WPCU's Code of Regulations requires that one half of one percent of our eligible voting membership must be represented in person or by writing, to constitute a legal Annual Business Meeting. Mr. Linsenmeyer acknowledged that more than 6,428 valid ballots from members were received for this year's meeting and accordingly the quorum requirements had been met. Mr. Linsenmeyer then declared the meeting to be a legal meeting.
- 4. Recognition of the Board of Directors, Executive Leadership, and Guests: Board Chair Linsenmeyer introduced his fellow board members and members of the executive leadership team:

- 5. Annual Report and Annual Meeting Minutes: Chair Linsenmeyer announced that the 2024 Annual Business Meeting Minutes, as contained in the Annual Business Meeting Notice, were approved by the membership by ballot and announced that the Annual Report and Meeting Minutes will be provided digitally via a link on our website at www.WPCU.coop/Annual-Meeting.
- 6. **President's Comments:** Mr. Tim Mislansky, President/ CEO, shared we have more than 520,000 members and remain financially strong, with total assets exceeding \$9 billion, which allows WPCU to offer extraordinary-personalized service, competitive rates, and lower-to-no fees.

In 2024 WPCU was honored to be named the Distinguished Air Force Credit Union of the Year for the second year in a row and the Community Supporter of the Year by the Dayton Business Journal. Mr. Mislansky shared that what truly matters to WPCU is how we help members.

7. Retail Loan Numbers / Financial + Save to Win:

Mr. Linsenmeyer, shared that we helped more than 82,000 members borrow smarter which included car loans, opening a credit card, buying a home, and student loans.

On the Savings side, we helped nearly 99,000 members "Save Better" by taking advantage of our great rates with Money Market and Share Accounts. We paid almost \$188 million dollars in dividends. We also introduced "Save to Win," which is a way to help members build

savings and have a chance to win cash prizes with monthly, quarterly and annual drawings. So far, we have celebrated more than 1,600 member-winners and awarded over \$135,000 in Save to Win prizes.

In 2024 we helped more than 1,500 members by attending our financial learning classes and workshops. These were done via in-person and virtual. The classes focused on budgeting, saving, borrowing, and financial planning. Also, we helped members learn how to protect themselves from fraud by providing members with education and resources needed to spot and avoid fraud, as well as giving support needed if fraud does occur.

- 8. **Commercial Loans:** Mr. Linsenmeyer shared that our Member Business Services team in 2024 has helped 917 local business owners with more than \$280 million in business loans.
- 9. Community Impact & Sunshine Community Fund®:
 The Sunshine Community Fund, the charitable giving arm of Wright-Patt Credit Union, works closely with nonprofits that help improve, strengthen, and safeguard the financial security of vulnerable populations within our community. Ms. Szarzi-Fors announced the fund is putting forth \$1.3 million through partnerships that are a part of the Northwest Dayton Pathways to Homeownership program to build 10 homes in Northwest Dayton so more residents can achieve homeownership. The Sunshine Community Fund will work with business partners, companies and philanthropic foundations to secure gifts and grants for the program. Ms. Geyer shared a story regarding

- two members who jointly secured a WPCU Sunshine Community Fund Bright Start Grant, which is a \$2,500 matching grant for down payment and closing costs for first-time home buyers who qualify.
- 10. 2025 and Beyond: Mr. Tim Mislansky, President/CEO, looked forward into 2025 and shared that we will be breaking ground on three new Member Centers one in Tipp City and two in Columbus; and the Polaris Parkway Member Center opened in March. He also shared card enhancements which include the "Tap to Pay" cards will be delivered to all credit card holders by the end of 2025, streamlined eStatements process, single centralized card center to help manage all your different WPCU card types in one convenient location. Also, enhanced security features including temporary card disablement, real-time transaction alerts, and self-serve travel notices. We are working on the ability to see credit card transactions in real time, and we are upgrading the interactive call and voice response system to a new platform for improved call routing, self-service options and faster and more personalized support.
- Results of the 2024 Directors Election: Chair Mr.
 Linsenmeyer announced that David Cassity, Nick
 Endsley and Adam Scheetz were elected to three-year
 terms on the WPCU Board of Directors.
- 12. **Adjournment:** Chair Mr. Linsenmeyer concluded that all the official business was complete, the 2025 Annual Business Meeting was adjourned and invited members to stay for a live question-and-answer session. The meeting ended at 7:55 pm.
