Wright-Patt Credit Union Announces New Senior Leadership Structure

Newly Created Positions

Market President - Columbus: Earlier this year, WPCU also established a new position for a Columbus Market President, held by Todd Elliott. In this role, Elliott will lead WPCU's expansion efforts in the Columbus, Ohio market. Elliot joined WPCU after 16 years at JP Morgan Chase where he served as Vice President – Business Banking Area Manager.

Chief Operating Officer: Rosanne Schutzman will be taking on the role of Chief Operating Officer. As Chief Operating Officer, Schutzman will lead: service delivery, Columbus, Ohio Market, information technology, project management, Retirement Solutions and fraud prevention. Schutzman has served WPCU for more than six years and prior to that worked as Vice President of IT for American Modern Insurance Group for seven years.
